#### **Overview**

#### FOR THE 2024/2025 FASFA PLEASE USE 2022 TAXES

We suggest you (and your spouse or parents) to use the IRS Direct Data Exchange Tool on your FAFSA to transfer Federal tax information directly from the IRS to your FAFSA.

If 2022 income tax return information for the you or your parents was not available or could not be used, you (student) and parents should provide the institution with a 2022 IRS Tax Return Transcript(s) or a signed copy of the 2022 income tax return and applicable schedules.

#### A 2022 IRS Tax Return Transcript may be obtained through:

- 1. Get Transcript by Mail Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- 2. Get Transcript Online Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- 3. Automated Telephone Request 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- 4. Visit an IRS Office near you (an appointment may be required)
